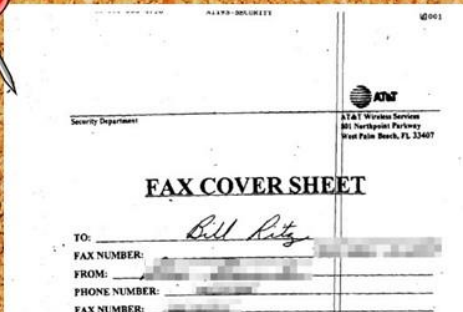

Building a Case

Watch any crime show, and you will see a quintessential crime board with pinned evidence that gives detectives a visual when building their investigation case. In this same manner, you are going to build two evidence boards: One board will showcase all of the evidence that makes Adnan look innocent (background knowledge from past episodes) and one board will showcase all of the evidence that makes Adnan look guilty (new evidence from episode 6).
